Emissions reduction targets

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We are committed to reduce Scope 1 and 2 market-based GHG emissions from our 2022 baseline by at least 50% by 2030, 80% by 2040, and be 100% carbon neutral in our operations by 2050.

Carbon Reduction Projects

The following environmental management measures and projects have been implemented since the 2022 baseline.

Generation of General Office Waste

Objective

To reduce total amount of waste.

Target

Reduction of waste where possible.

Action, Improvement or Control

Recycling posters Recycling bins/facilities available Eliminate single use items.

Electricity - Renewable Supplier

Objective

To increase amount of electricity purchased from renewable providers.

Target

To purchase energy from a renewable energy provider by 31/03/2028.

Action, Improvement or Control

Source a renewable energy provider Investigate on site renewable sources e.g., solar / wind.

Car Fleet Emissions

Objective

To reduce the average overall C02 emissions of the company car fleet.

Target

To reduce emissions by 31/03/2030

Action, Improvement or Control

Educate employees on maintenance of their vehicles and raise awareness on fuel efficiency. Purchase/Lease electric cars when financially viable and with an increase in charging locations.

Electricity - Lighting and general use

Objective

To reduce the amount of energy used by the organisation in relation to lighting and general office use.

Target

To reduce amount of electricity used by 50% by 31/03/2030.

Action, Improvement or Control

Posters reminding to turn off lights, computers and other electrical items up in office. Change all lighting to energy saving alternatives. Replace high energy rated appliances with lower energy rated versions where and when viable.

Transportation - Receiving and delivery of goods.

Objective

Use the lowest impact transport method available.

Target

Reduction of c02 emissions

Action, Improvement or Control

Change to lower emissions transportation options e.g. couriers who use electric vehicles. To request environmental policies from delivery companies used.

Declaration and Sign Off

This Carbon Reduction Plan has been completed in accordance with PPN 06/21 and associated guidance and reporting standard for Carbon Reduction Plans.
